Ageing and intergenerational relations

Objectives

The aim of the course is to familiarise the students with the analysis of the intergenerational transfers in an ageing society with a macro/micro perspective. The demographic context of intergenerational exchanges will be firstly analysed showing its changes over time and space. Subsequently, indicators and data sources will be considered to prepare the students to formulate appropriate research hypotheses and to test them empirically through statistical applications. Standard methods are presented and discussed through a worked example to provide students with the basic tools to apply quantitative methods to answer socio-demographic research questions. National and international data sources will be considered.
