Objectives

This course integrates a core demographic interest in family dynamics with a core sociological concern about social inequalities: how does the growing instability of the "traditional" nuclear family affect the reproduction of social inequalities? How do different childcare arrangements influence children's cognitive and non-cognitive development? The objective of this course is to understand whether and to what extent demographic and family changes have consequences on the well-being of families; how these changes are uniform across the population; and how these phenomena, considered as a whole, increase the distances between families (inequality) or reduce them (equality).

Program

Monday morning (Instructor: R. Guetto):

A demographic reversal: the changing socioeconomic gradients in Second Demographic Transition-related behaviour; the Diverging Destinies Thesis.

Tuesday afternoon (Instructor: C. Pronzato):

Childcare arrangements for young children: Determinants and consequences for mothers' employment, couple decisions about fertility, and child development; Inequality issues.

Wednesday morning (Instructor: C. Pronzato):

Children's use of time: Determinants and consequences on children's non-cognitive development; Inequality issues.

Thursday morning (Instructor: R. Guetto):

Family instability and its heterogeneous consequences for children's outcomes.
